Sold \$ 5005 in Season Passes. \$ 12500 in sponsorship monies received. \$1805 in carnival passes. Royalty Program – interest approximately 6 for queen and 1 king. Little miss and princess apps coming soon.

Promotions (Advertising, Website, Social Media), Recruitment, and Volunteers Committee Report: Website training started. The committee will meet shortly to finalize it so it can go live. Goal of 21st. Advertising continuing and hitting some stations in Cedar Falls

Capital Improvements, Maintenance, Repairs and Events Prep Committee Report: Fence around office and a gate in front of grandstand – quote \$10762.25.

Pit Concessions – was built about 14 years ago with used materials. To replace stand with 12' x 24' with rough openings for window and walk-in door -\$7975.50(free shipping).
